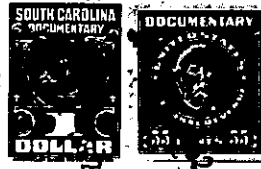

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said R. E. Scott, his heirs and assigns forever,

All that certain piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina, on the Southern side of Woodmont Lane, near the City of Greenville, being shown as lot No. 2 on a plat of Woodfields, recorded in Plat Book S at Pages 112 and 113, and described as follows:

BEGINNING at a stake on the Southern side of Woodmont Lane, 94.1 feet West from Crestfield Road, at corner of lot No. 1, and running thence with the line of said lot, S. 14-11 W. 179.5 feet to an iron pin; thence N. 79-45 W. 70 feet to a stake at corner of Lot No. 3; thence with the line of said lot, N. 14-11 E. 179.5 feet to a stake on Woodmont Lane; thence with the Southern side of Woodmont Lane, S. 79-45 E. 70 feet to the beginning corner.

Being the same property conveyed to the Grantor by deed recorded in Deed Book 575 at Page 198.

As a part of the consideration for this conveyance, the Grantee assumes and agrees to pay the unpaid balance due on a mortgage recorded in Mortgage Book 711 at Page 1.
