 in consideration of the sum of Eleven Thousand Two Hundred Fifty and no/100----- DOLLARS,

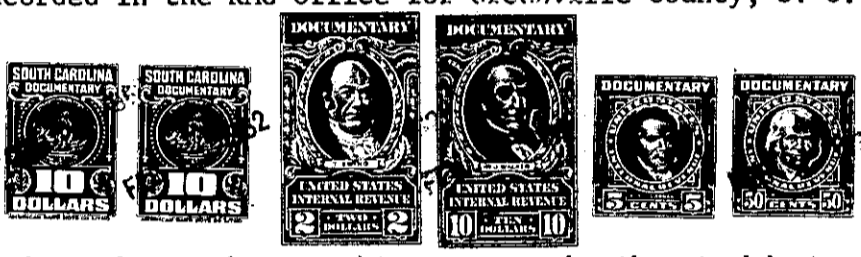

ALL that lot of land with the buildings and improvements thereon, situate on the South side of Miami Avenue, near the City of Greenville, in Greenville County, S.C. being shown as Lot No. 9 on plat of Spring Brook Terrace, made by J. Mac Richardson, Engineer, March 1958, recorded in the RMC Office for Greenville County, S. C. in Plat Book KK, page 143, and having according to said plat the following metes and bounds, to wit:
