

Norris Smith, on the south by property now or formerly belonging to Charles R. and Gladys E. Gosnell, on the west by property now or formerly belonging to Gordon Smith, on the north by property now or formerly belonging to the W. D. Smith Estate, being known and designated as Tract No. 180.1 as shown on a plat entitled "Property Ownership Map Prepared for the Greenville-Spartanburg Airport Commission," dated June 23, 1960, prepared by Piedmont Engineering Service, and having, according to a plat entitled "Property of W. Smith and to the W. D. Smith Estate; thence with the line of said Smith Estate property S. 89-08 E. 495.7 feet to an iron pin in or near said Old Greer-Pelham Road and in the line of property now or formerly belonging to E.
