

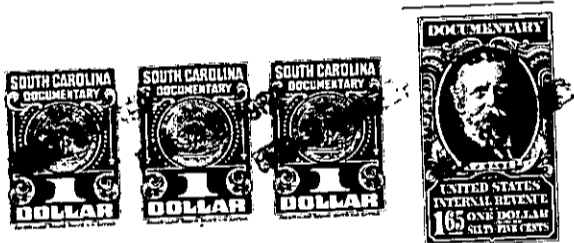

KNOW ALL MEN BY THESE PRESENTS, that Leslie & Shaw, Inc., a Corporation chartered under the laws of the State of South Carolina and having a principal place of business at Greenville, State of South Carolina, in consideration of Twelve Hundred and no/100 Dollars, the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto J. P. Medlock, his heirs and assigns:

All that certain piece, parcel or lot of land situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as lot #20, as shown on a plat of Oakwood Acres, prepared by J. Mac Richardson, dated September 1959, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book M1, at Page 135, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Live Oak Way, the joint front corner of lots #20 and #19, and running thence along the line of these lots, N. 67-05 E. 188.9 feet to an iron pin in the property line now or formerly known as Crain property; running thence S. 17-13 W. 72.9 feet to an iron pin; thence S. 87-17 E. 80 feet to an iron pin at the joint rear corner of lots #20 and #21; running thence S. 67-05 W. 213.8 feet to an iron pin on the eastern side of Live Oak Way; running thence along the eastern side of Live Oak Way N. 22-55 W. 90 feet to an iron pin, point of beginning.
