All that certain piece, parcel or lot of land, situate, lying and being at the northwestern corner of the intersection of Pimlico and Shelburne Roads in the City of Greenville, County of Greenville, State of South Carolina being known and designated as Lot #103 as shown on a plat prepared by Dalton and Neeves, dated January, 1960, entitled "Section A, Map of Gower Estates", recorded in the R. M. C. Office for Greenville County in Plat Book QQ at pages 146 and 147 and having according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the southwestern side of Pimlico Road at the joint front corners of Lots #103 and #104 and running thence with the line of Lot #104 S. 67-46 W. 188.4 feet to a point in the center of a branch at the joint rear corners of Lots #12, #13, #103 and #104; thence with the aforesaid branch as the line, the traverse line being S. 2-46 E. 116.8 feet, to a point on the northern edge of Shelburne Road; thence with the northern side of Shelburne Road N. 70-17 E. 203 feet to an iron pin; thence with the curve of the intersection of Shelburne Road and Pimlico Road, the chord of which is N. 24-01 E. 34.5 feet, to an iron pin on the southwestern side of Pimlico Road; thence with the southwestern side of Pimlico Road N. 22-14 W. 95 feet to the point of beginning.


