the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Edgar Ivester and Clarice D. Ivester, their heirs and assigns forever:

ALL that piece, parcel or lot of land in Greenville County, State of South Carolina, being known and designated as Lot No. 57, as shown on a Plat of Valencia Estates by W. N. Willis, Engineers, dated November 1960, recorded in the R. M. C. Office for Greenville County in Plat Book MM, at Page 179, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on Toledo Street, joint front corners of Lots Nos. 57 and 58 and running thence along the line of said lots, N. 82-54 W. 241.4 feet to iron pin rear line of Lot 63; thence running with rear line of said lot, S. 21-19 W. 87.6 feet to iron pin rear corner of Lot 64; thence running S. 83-08 E. 263 feet to iron pin on Toledo Street; thence running with Toledo Street, N. 56-30 E. 75 feet to iron pin at point of beginning.

NO residence to cost less than Ten Thousand (\$10,000.00) Dollars shall be erected on any lot; no residence shall be erected on lots nearer than thirty-five (35) feet to the front line; no residence shall be built on any lot unless said lot has 70 feet, or more, frontage; no outside toilets permitted and sewage to be disposed of by approved septic tanks; all lots to be used for residential purposes only.

THIS conveyance is subject to all easements and rights of way of record.
