the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

John H. Kennon Jr. and Ann Kluge Kennon, their Heirs and Assigns forever,

All that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, Chick Springs Township, about one mile east of Brushy Creek Baptist Church, lying on the north side of the said Brushy Creek Road (upper route) being a part of the same land conveyed to me by deed from H. K. Kluge May 4th 1953, recorded in the office of the R. M. C. for Greenville County in Deed Book 477 at page 374, and being shown as Lot No. 3 on Plat of Property of Lucile Annie Kluge made by H. S. Brockman, Surveyor, April 25th 1962, and having the following courses and distances, to wit:-

Beginning on an iron pin in the center of a new proposed road and on the Moore line, said iron pin being 310 feet from the center of the Brushy Creek Road, and being the joint corner of Lots Nos. 2 and 3 as shown on said plat, and runs thence with the center of the said proposed new road and the Moore line, N. 24-00 W. 105 feet to a stake in the center of the said proposed road and on the Moore line; thence S. 66-00 W. 20 feet to an iron pin, then continuing with the same course for a total distance of 209 feet to an iron pin on the Morris Smith Sud-division line; thence with the common line of the Morris Smith property and of my property, S. 18-45 E. 105.4 feet to an iron pin, joint corner of Lots Nos. 2 and 3; thence with the common line of the said two lots, N. 66-00 E. 218.6 feet to the beginning corner, containing Fifty One One-hundredths (0.51) of one acre, more or less.
