Know All Men by These Presents:

That I, Robert W. Wells in the State aforesaid, in consideration of the sum of One and no/100-(\$1.00) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Greenville County, its successors and assigns, for road purposes.

ALL that piece, parcel or lot of land situate, lying and being in Gantt Township, Greenville County, State of South Carolina, and being east of the Augusta Road, five (5) miles from the Greenville County Courthouse, being known as a small portion of Lot No. 1 on plat of property of Julia D. Charles, made by W. J. Riddle, Surveyor, September, 1936, and according to a later plat made by C. C. Jones having the following metes and bounds, to-wit:

BEGINNING at an iron pin in the center lot line of Lot No. 138 of a subdivision known as Belmont Heights, plat of which is recorded in the RMC Office for Greenville County, S. C., in Plat Book "GG" at Page 99, and running thence N 43-19 E 128.9 feet to an iron pin; running thence N 50-32 E 586.3 feet to an iron pin; running thence N 29-58 W 50.4 feet to an iron pin; running thence S 50-32 W 599.4 feet more or less, to an iron pin; thence continuing along said avenue S 43-19 W. 157.5 feet to an iron pin in the line of property now or formerly of Knox; running thence S 26-45 W. 48.2 feet; running thence N 49-54 E 41.7 feet to an iron pin; point of beginning.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and its Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
