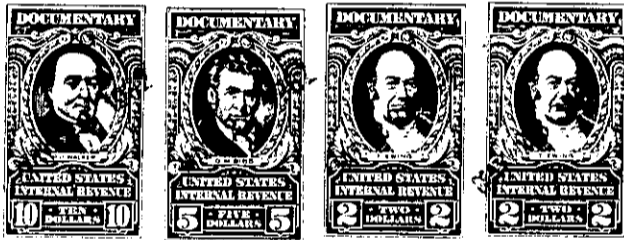
KNOW ALL MEN BY THESE PRESENTS, that I, Levis L. Gilstrap, of Greenville County,
