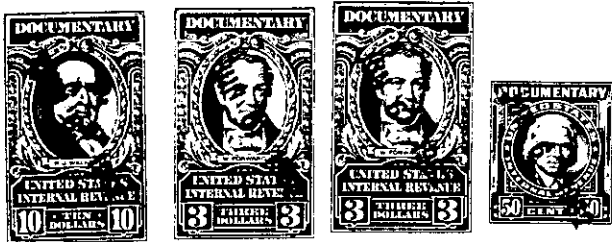

All that certain piece, parcel or lot of land situate, lying and being in the
State of South Carolina, County of Greenville, Being known and designated as
lot #12, of a subdivision known as Edwards Forest as shown on a plat thereof
prepared by Woodward Engineering Co., dated Feb. 22, 1955, and recorded in
the R. M. C. Office for Greenville County in Plat Book EE, at Page 105, and
having according to said plat, the following metes and bounds, to-wit:
