The purchase price which the Buyer shall pay for the said lots is the sum of \$ 4,500.00.
which money shall be paid as follows: \$200.00 in cash, the receipt of which is hereby acknowledged; and
the balance shall be bala on hoothly installments of \$50.00 each, beginning one month from this date, the deferred payments to bear interest at the rate of 6% per annum.
All deferred payments are to be madexaxthex deposited to the account of T.
After 36 monthly payments the seller and buyer is to take mortgage and maked and payable, the Seller convenants to convey the said property and interest thereon as the same becomes or his assigns, by deed with general warranty, free and clear of all liens and encumbrances, save and except taxes not now due and payable and subject to the reservations and conditions set forth herein and on said plat.

This contract is executed by the Buyer with the understanding and agreement that the property herein described has been inspected by the Buyer, or his duly authorized agent, and has been purchased by the Buyer solely as the result of such inspection, and the agreement herein contained, and not upon any inducements, representations, agreements, conditions or stipulations by any person whatsoever not fully set forth herein, and this Contract for Deed embodies the entire agreement between the Seller and the Buyer relative to the property described herein.
