unto **John W. Shealey and Vera Myrtis Shealey, their heirs and assigns forever:**

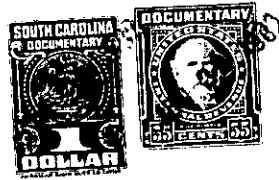
