KNOW ALL MEN BY THESE PRESENTS, that we, Boyce H. Pinson and Juanita P. Pinson,

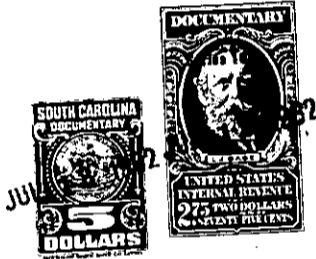
in consideration of Twenty Two Hundred and No/100 (\$2200.00)----- Dollars,

All that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, on the northeastern side of Lancaster Lane and being known and designated as Lot No. 292, Section 3 of Belle Meade as shown on plat thereof recorded in the R.
