C. E. Robinson^{Jr.} and R. M. Gaffney, their heirs and assigns:

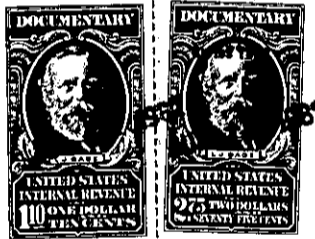
All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, being known and designated as lot #70 of a subdivision known as Wellington Green as shown on a plat thereof prepared by Piedmont Engineering Service, dated October, 1961, recorded in the R.M.C. Office for Greenville County, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Melbourn Lane, the joint front corner of lots #70 and #71, and running thence along the line of these lots, S. 30-23 W. 182.1 feet to an iron pin in the line of lot #77; running thence N. 60-13 W. 99.7 feet to an iron pin at the joint rear corner of lots #70 and #69; running thence N. 30-23 E. 183.2 feet to an iron pin on the southern side of Melbourn Lane; running thence along the southern side of Melbourn Lane S. 59-37 E. 100 feet to an iron pin, point of beginning.

The above described lot is a portion of that property conveyed to me by Cora C. Howell by her Deed dated April 9, 1914, and recorded in the R.M.C. Office for Greenville County in Deed Vol. 60, at page 130.
