in consideration of One Thousand and No/100 - - - - - (\$1,000.00) 5 707 and assumption of mortgage set out below the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release Jarrett Fred Trotter, his heirs and assigns forever:

All that certain piece, parcel, or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 84 according to a plat of a subdivision known as Chestnut Hills No. 1 prepared August 28, 1959 by R. K. Campbell, Surveyor, and recorded in the R.M.C. Office for Greenville County in Plat Book QQ, at page 83, and having, according to said plat, the following metes and bounds, to-wit:
