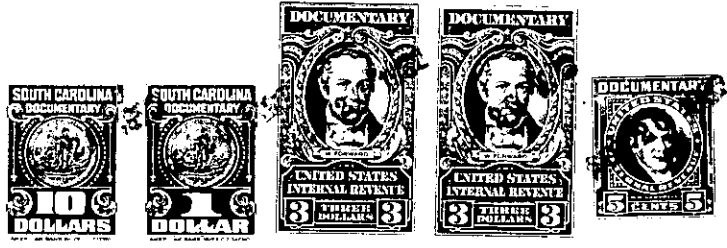

G. Proffitt, his heirs and assigns forever,

All that lot of land in Greenville County, State of South Carolina, being shown as Lot 326 on the Southern side of Bridgewater Drive, on a plat of Botany Woods, Sector VII, recorded in Plat Book YY at pages 76 and 77, and described as follows:

BEGINNING at an iron pin on the Southern side of Bridgewater Drive at the joint front corner of Lots 325 and 326 and running thence with the line of Lot 325, S. 17-21 E. 190 feet to an iron pin; thence N. 68-16 E. 130.5 to an iron pin, corner of joint rear lines of Lot 326 and 327; thence with the line of Lot 327, N. 17-21 W. 180 feet to an iron pin on Bridgewater Drive; thence with said Bridgewater Drive, S. 72-39 W. 130 feet to point of Beginning.
