in the State aforesaid, in consideration of the sum of Ten Thousand Nine Hundred and no/100 (\$10,900.00)---DOLLARS,

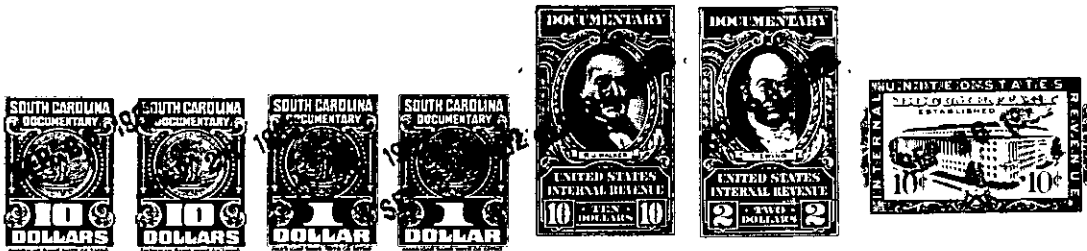

All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, being shown as Lot No. 42 on a plat of Shamrock Acres, recorded in the R.M.C. Office for Greenville County in Plat Book YY, Page 43 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the easterly side of Shamrock Circle at the joint front corner of lots 41 and 42 and running thence with the common line of said lots N. 57-16 E. 194.6 feet to an iron pin; thence N. 16-34 W. 88.5 feet to an iron pin; thence S. 57-16 W. 219.3 feet to an iron pin on the easterly side of Shamrock Circle; thence with said Circle S. 32-44 E. 85 feet to the point of beginning.
