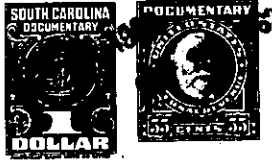

unto W. Jack Lamb and Marie Lamb, their heirs and assigns forever:

ALL that piece, parcel or lot of land in the State and County aforesaid, being known and designated as Lot 53, as shown on a plat of Wynette Estates by Pickell and Pickell, Engineers, dated July 1953, recorded in the R. M. C. Office for Greenville County in Plat Book EE, at Page 37, and having according to said plat, the following metes and bounds, to-wit:
