CHARTER

BY THE SECRETARY OF STATE

WHEREAS,

FIRST: That their names and residences are as above given.

SECOND: That the name of the proposed corporation is HUNT DEVELOPMENT COMPANY, INC.

THIRD: That the principal place of business is South of CAYCE, S. C.

FOURTH: That the general nature of the business which it is proposed to do is borrow money, construct buildings, enter into leases for the same, and other matters incidental to the ownership and control of its properties.
