

All that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid, Oneal Township, about two miles north of Greer, S. C., lying in the new location of State Highway No. 14 and on the east side of said new location of highway No. 14, and being a part of the same plot of land conveyed to me by deed from H. J. Lanford May 26th 1949, recorded in the office of the R. M. C. for Greenville County in Deed Book 383 at page 269, and having the following courses and distances, to wit:-

Beginning on an iron pin on a branch and being on or near the eastern edge of the Right of Way of the said highway No. 14, and runs thence with the common line of tracts 12 and 13 as shown on plat of property of S. J. Morgan made by H. S. Brockman, Surveyor, November 19th 1941, N. 8-20 E. 214 feet to an iron pin on the said line; thence a new line, S. 64-00 W. 103.5 feet to an iron pin on the eastern edge of the said mew location of highway No. 14, then continueing with the same course for a total distance of 206 feet to a point in the said highway which was in an old abandonded road; thence with the former location of the said old road (but now within the new location), S. 28-00 E. 162.7 feet to a point within the said highway (formerly an old Black Cum corner); thence down the former location of a branch N. 74-00 E. 81 feet to the beginning corner, containing Fifty Seven One-hundredths (0.57) of one acre. About one-half of this area is within the Right of Way of the said new location of Highway No. 14.
