to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named, (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto **BOBBY R. PRIDMORE:**

All that piece, parcel or lot of land situate, lying and being on the Western side of Michael Drive near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 5 as shown on a plat of Michael Park, prepared by C.C. Jones, Engineer, dated August, 1961, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book XX at page 21, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Western side of Michael Drive at the joint front corner of Lots Nos. 4 and 5, and running thence with the line of Lot No. 4 N. 59-20 W. 155 feet to an iron pin in the line of property now or formerly of R.M. Kennedy; thence with the line of the said Kennedy property S. 30-46 E. 80 feet to an iron pin at the joint rear corner of Lots Nos. 5 and 6; thence with the line of Lot No. 6 S. 59-20 E. 155 feet to an iron pin on the Western side of Michael Drive; thence with the Western side of Michael Drive N. 30-46 E. 80 feet to the point of beginning.

Office for Greenville County, South Carolina.
