ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 39 of the Property of Wm. R. Timmons, Jr., according to a plat of record in the R. M. C. Office for Greenville County in Plat Book XX at Page 9, and having the following metes and bounds, to wit:

BEGINNING at a point on the Northwestern side of Childress Drive at the joint corner of Lots 36 and 39 and running thence with the Northwestern side of Childress Drive S 46-08 W 95.3 feet to a point; thence continuing with the Northwestern side of Childress Drive S 50-07 W 91.7 feet to a point; thence following the curvature of the Northern intersection of Childress Drive with Fairfax Drive (the chord of which is N 81-46 W 27.7 feet) to a point; thence with the Northeastern side of Fairfax Drive N 37-48 W 77.6 feet to a point; thence continuing with the Northeastern side of Childress Drive N 43-53 W 24.6 feet to a point at the joint front corner of Lots 39 and 40; thence N 39-17 E 153.9 feet to a point at the joint rear corner of Lots 39 and 40; thence S 60-20 E 154.2 feet to the point of BEGINNING.
