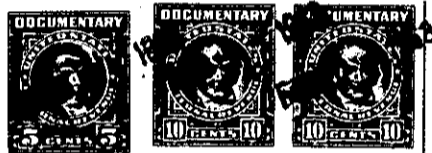
KNOW ALL MEN BY THESE PRESENTS, that

ALL that certain piece, parcel or lot of land with the buildings and improvements thereon, situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known as Lot 13, according to a plat of property of Leslie and Shaw, Inc. dated February, 1957, and recorded in the office of the R. M. C. for Greenville County, S. C. in Plat Book NN, at page 3, and having according to said plat the following metes and bounds, to-wit:
