Raymond M. Painter and Dorothy M. Painter, their heirs and assigns forever

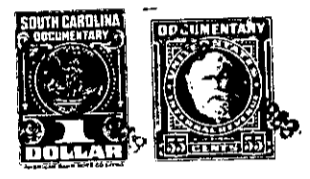
