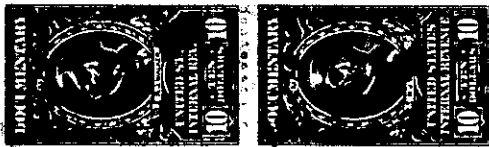

KNOW ALL MEN BY THESE PRESENTS, that I, William M. Gray.

in consideration of Twenty Two Thousand Five Hundred and no/100----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Charles B. Bowen, his heirs and assigns,

All those certain pieces, parcels or lots of land in Greenville County, State of South Carolina, on the western side of Windemere Drive, in Chick Springs Town-ship, being shown and designated as Lots Nos. 44 and 45 on Map No. 2 of Cherokee Forest, recorded in Plat Book EE at page 191 and having, according to said plat, the following metes and bounds, to wit:

LOT NO. 44: Beginning at an iron pin on the western side of Windemere Drive, at the joint front corner of Lots Nos. 44 and 43, and running thence with the line of Lot No. 43, S. 56-30 W. 175 feet to an iron pin; thence S. 33-30 E. 100 feet to an iron pin at rear corner of Lot No. 45; thence with the line of Lot No. 45, N. 56-30 E. 175 feet to an iron pin on Windemere Drive; thence with the western side of Windemere Drive, N. 33-30 W. 100 feet to the point of beginning.

LOT NO. 45: Beginning at an iron pin on the western side of Windemere Drive, at the front corner of Lots Nos. 44 and 45 and running thence with the line of Lot No. 44, S. 56-30 W. 175 feet to an iron pin; thence S. 33-30 E. 100 feet to an iron pin in center of drainage easement and corner of Lot No. 46; thence with said drainage easement and line of Lot No. 46, N. 56-30 E. 175 feet to an iron pin on Windemere Drive; thence with the western side of Windemere Drive, N. 33-30 W. 100 feet to the point of beginning.

This conveyance is made subject to restrictive covenants recorded in Book of Deeds 568 at page 259 and Book of Deeds 568 at page 263, which are applicable to all lots shown on the above mentioned plat.
