

POWER OF ATTORNEY - LIMITED

KNOW ALL MEN BY THESE PRESENTS:

That I, ROBERT E. DOMINEY, a legal resident of the City (Town) of Greenville, County of Greenville, State of South Carolina, United States of America, now in the military service as a Captain, Serial Number A03061580 in the Air Force of the United States, and at present being stationed in said military service at Donaldson AFB, South Carolina have made, constituted and appointed and by these presents do make, constitute and appoint LONNETTE DOMINEY whose address is 12 Hillside Lane, Greenville, S.C., my true and lawful attorney to act in, manage, conduct, concur with persons jointly interested with myself therein, and do all or any of the following acts, deeds, and things, that is to say: To lease, rent, sell, or in any other manner to dispose of any or all of my interest in certain real property, located at Greenville, S. C. and known and designated by the street address 12 Hillside Lane, Greenville, S. C.///END///

GIVING AND GRANTING unto my said attorney full power and authority to do and perform all and every act, deed, matter, and thing whatsoever in the premises, as fully and effectively to all intents and purposes as I might or could do in my own proper person if personally present; and hereby ratify all that my said attorney shall lawfully do or cause to be done by virtue of these presents.

And I hereby declare that any act or thing lawfully done hereunder by my said attorney shall be binding on myself, and my heirs, legal and personal representatives and assigns; whether the same shall have been done before or after my death or other revocation of this instrument, unless and until reliable intelligence or notice thereof shall have been received by my said attorney; and whether or not I, the grantor of this instrument, shall have been reported or listed, either officially or otherwise, as "missing" or "missing in action" as those words are used in military parlance, it being the intent hereof that such status designation shall not bar my attorney from fully and completely exercising and continuing to exercise any and all powers and rights herein granted, and that such report of "missing" or "missing in action" shall neither constitute nor be interpreted as constituting notice of my death nor operate to revoke this instrument.

IN WITNESS WHEREOF, I have hereunto set my hand and seal the 25th day of January nineteen hundred sixty-three. This power shall terminate on 1 July 1963 unless (sooner) revoked by me.
