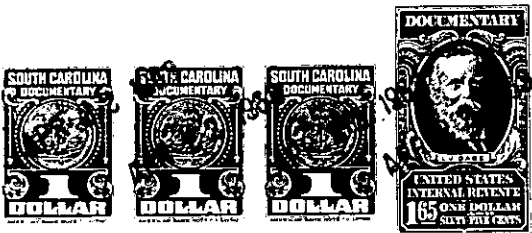

KNOW ALL MEN BY THESE PRESENTS, that W. N. Leslie, Inc. a Corporation chartered under the laws of the State of South Carolina and having a principal place of business at Greenville, State of South Carolina, in consideration of Twelve Hundred and no/100 Dollars, the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto J. P. Medlock, his heirs and assigns:

All that piece, parcel or lot of land situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot #50, as shown on a plat of Oakwood Acres, Section 2, prepared by Piedmont Engineering Service, dated May 1962, and recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book AAA, at Page 38, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Oakwood Avenue, the joint front corner of lots #50 and #51, and running thence along the line of these lots, N. 82-30 W. 182.0 feet to an iron pin; thence N. 16-30 E. 122.8 feet to an iron pin on the southern side of Holly Knoll Drive; thence along the southern side of Holly Knoll Drive S. 70-32 E. 150.0 feet to an iron pin at an intersection, which intersection is curved, the chord of which is S. 18-53 E. 32.5 feet to an iron pin on the western side of Oakwood Avenue; thence along the western side of Oakwood Avenue S. 7-30 W. 68.4 feet to an iron pin, point of beginning.
