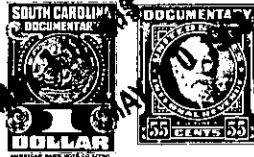

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release  
unto Michael Southers, his heirs and assigns,

ALL that certain piece, parcel or lot of land in Austin Township, Greenville County, State of South Carolina, within the corporate limits of the City of Mauldin and being known and designated as Lot No. 80, of a subdivision known as Glendale, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book QQ, pages 76 and 77, and having, according to said plat the following metes and bounds, to-wit:

BEGINNING at a point on the Southern side of Fairfield Drive at the joint front corner of Lots 79 and 80 and running thence S. 11-16 W. 155 feet to a point at the joint rear corner of Lots 79 and 80; thence N. 78-44 W. 95 feet to a point at the joint rear corner of Lots 80 and 81; thence N. 11-16 E. 155 feet to a point on the Southern side of Fairfield Drive at the joint front corner of Lots 80 and 81; thence with the Southern side of Fairfield Drive, S. 78-44 E. 95 feet to the point of Beginning.
