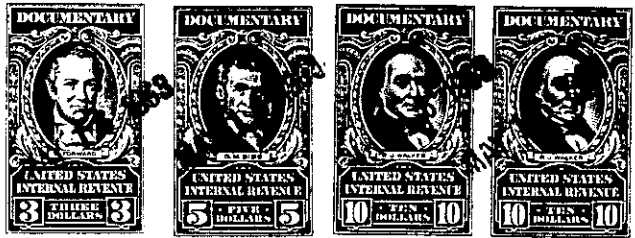

in consideration of Twenty-Five Thousand, Five Hundred and No/100-----(\$ 25,500.00)---- Dollars,
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto
Mary Alice H. Brown, her heirs and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, being known and designated as Lot No. 34, of a subdivision known as "ADDITION TO WILDAIRE ESTATES", according to a plat thereof prepared by Piedmont Engineering Service, November 1962, and recorded in the R. M. C. Office for Greenville County in Plat Book RR, at Page 100, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the northern side of Ramblewood Drive, the joint front corner of Lots #34 and #35, and running thence along the line of these lots, N. 61-31 W. 180.1 feet to an iron pin in the line of Lot #41; thence along the rear line of Lot #41, N. 11-30 E. 45.0 feet to an iron pin at the joint rear corner of Lots #33 and #34; running thence S. 85-42 E. 177.3 feet to an iron pin on the northern side of Ramblewood Drive; thence along the northern side of Ramblewood Drive, which line is curved, the chord of which is S. 13-20 W. 120.0 feet to an iron pin, point of beginning; being the same conveyed to me by W. E. Shaw, Inc. by deed dated May 14th, 1963, to be recorded herewith.
