KNOW ALL MEN BY THESE PRESENTS, that Jack E. Shaw and Herbert E. Rudd,

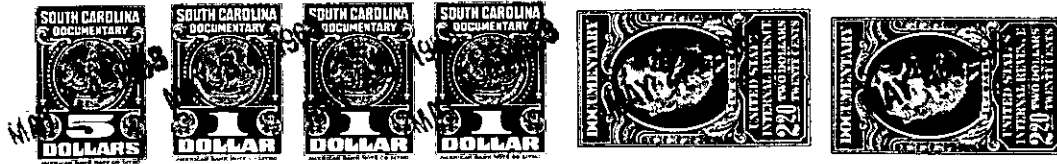
in consideration of Three Thousand Nine Hundred Fifty and no/100----- Dollars,

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, being known and designated as Lot No. 102 of a subdivision known as Orchard Acres, Section Two, as shown on a plat of a position of said subdivision prepared by J. Mac Richardson, Surveyor, March 1960. and recorded in the R. M. C. Office for Greenville County in Plat Book QQ, at Page 6, and having, according to said Plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern edge of Ridge Spring Street, joint front corner of Lots Nos. 101 and 102, and running thence along the joint line of said lots, S. 4-24 E. 175 feet to an iron pin on the rear line of Lot No. 121; thence along the rear lines of Lots Nos. 121 and 120, N. 85-36 E. 90 feet to an iron pin at the rear corner of Lot No. 103; thence along the line of that lot, N. 4-24 W. 175 feet to an iron pin on the southern edge of Ridge Spring Street; thence along the southern edge of Ridge Spring Street, S. 85-36 W. 90 feet to the beginning corner; being the identical property conveyed to the grantors by deed of Greenville Land Co., Inc., dated April 13, 1962, and recorded in the R.M.C. Office for Greenville County in Deed Vol. 696, at Page 295.

This conveyance is subject to restrictions and protective covenants recorded in the R.M.C. Office for Greenville County in Deed Vol. 648, at page 169, and is also subject to such drainage and utility easements as appear of record.

The Grantee herein accepts this property subject to that certain note and mortgage executed by the Grantors herein to Carolina Federal Savings & Loan Association, recorded in the R. M. C. Office for Greenville County in Mortgage Book 887, Page 301, which has a present balance of \$12,976.90.
