KNOW ALL MEN BY THESE PRESENTS, that **McCALL-THREATT ENTERPRISES, INC.**

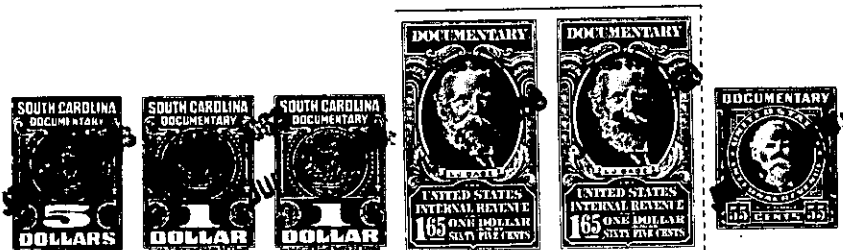

All that certain lot of land in Greenville County, State of South Carolina, on the southwestern corner of Spartanburg Road and Butler Springs Road, near the City of Greenville, being shown as lot # 6 on a plat of Spring Forest, recorded in the RMC office for Greenville County in Plat Book XX at Page 126, and described as follows:

BEGINNING at an iron pin on the south side of Old Spartanburg Road, at the corner of Butler Springs Road, and running thence with the curve of the intersection, the chords of which are: S. 50-43 E. 65 feet and S. 31-47 E. 65 feet to iron pin on Butler Springs Road; the corner of lot 5; thence with the line of said lot, S. 67-10 W. 206.3 feet to iron pin in the line of lot 34; thence with line of said lot, N. 33-50 W. 40 feet to iron pin at the corner of lot 7; thence with the line of said lot, N. 41-43 E. 191.9 feet to the beginning corner.
