the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

JAMES L. HADAWAY, JR. AND SANDRA P. HADAWAY, THEIR HEIRS AND ASSIGNS:

ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 36 of the Property of Wm. R. Timmons, Jr., according to a plat of record in the R. M. C. Office for Greenville County in Plat Book XX at Page 9, and having the following metes and bounds, to wit:

BEGINNING at a point on the Southwestern side of Larkspur Drive at the joint front corner of Lots 35 and 36 and running thence with the Southwestern side of Larkspur Drive S 70-05 E 35.2 feet to a point; thence following the curvature of the Southwestern intersection of Larkspur Drive with Childress Drive (the chord of which is S 47-34 E 37 feet) to a point, thence with the Southwestern side of Childress Drive S 25-02 E 143.6 feet to a point; thence following the curvature of Childress Drive (the chord of which is S 10-33 W 66.4 feet) to a point; at the joint front corner of Lots 36 and 39; thence N 60-20 W 184.2 feet to a point at the joint rear corner of Lots 35 and 36; thence N 19-55 E 150 feet to the point of BEGINNING.
