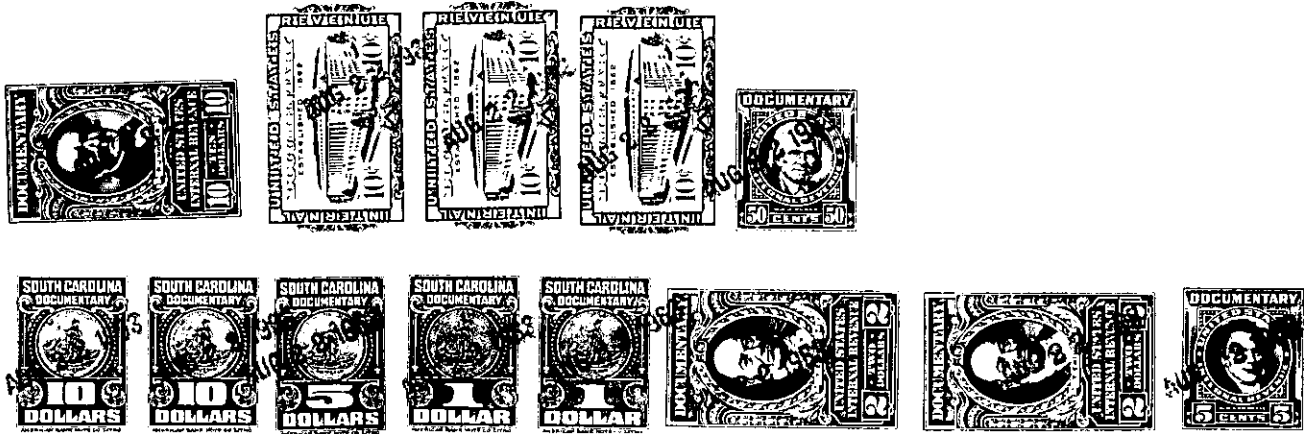
KNOW ALL MEN BY THESE PRESENTS, that I, E. C. Elliott, of Greenville County,

All that certain piece, parcel or lot of land in Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 9 of the Property of Wm. R. Timmons, Jr., according to a plat of record in the R. M. C. Office for Greenville County in Plat Book XX, at Page 9, and having the following metes and bounds, to-wit:
