

Douglas Estate, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book F at page 126, and having according to a more recent plat prepared by C.C. Jones, Engineer, dated February 19, 1962, entitled "Property of Dempsey Window Co., Inc.", the following metes and bounds:

BEGINNING at an iron pin at the Southeastern corner of the intersection of Edgemont Avenue and Cothran Street, also known as Enoree Street, and running thence with the Southern side of Edgemont Avenue S. 60-18 E. 139.9 feet to an iron pin; thence continuing with the Southern side of Edgemont Avenue S. 63-32 E. 75.1 feet to an iron pin at the joint front corner of Lots Nos. 73 and 74 as shown on the first plat referred to hereinabove; thence with the line of Lot No. 73 S. 31-50 W. 66.4 feet to an iron pin; thence a new line through Lots Nos. 74, 75 and 76 N. 59-0 W. 220 feet to an iron pin on the Eastern side of Cothran Street, also known as Enoree Street; thence with the Eastern side of Cothran Street, also known as Enoree Street N. 33-13 E. 57.3 feet to the point of beginning.
