KNOW ALL MEN BY THESE PRESENTS, that I, Florrie E. Greer, North R.M.C.

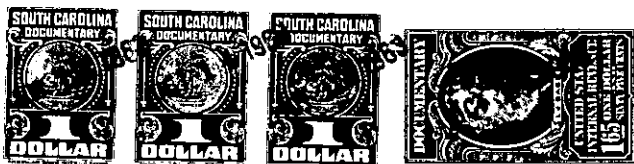
in consideration of Twelve Hundred Seventy Five and No/100 --(1,275.00) Dollars,
