That I, J. Frank Williams

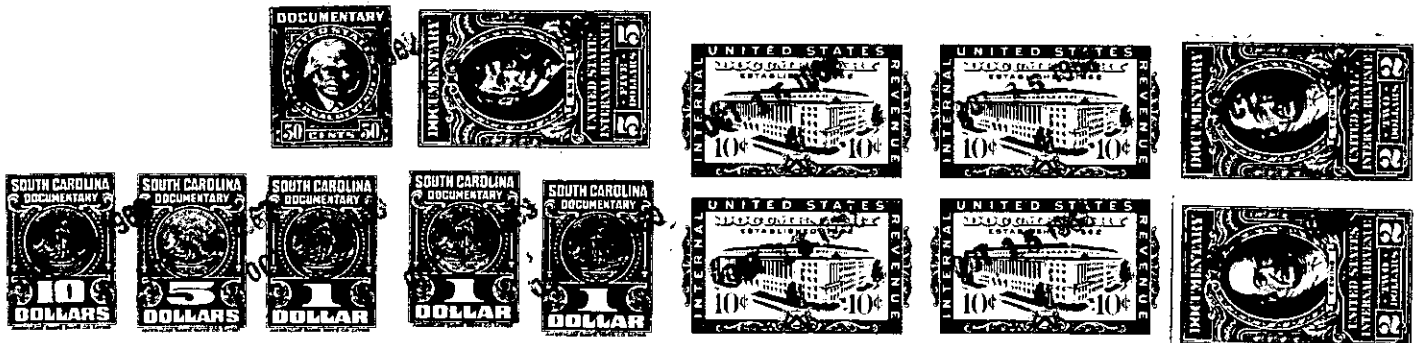
in consideration of the sum of Eighty Seven Hundred Fifty and no/100 (\$8750.00) - - DOLLARS,
