G. Bishop, his heirs and assigns, forever:

All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, and being shown as Lot No. 80 on a plat of Western Hills, recorded in the RMC Office for Greenville County in Plat Book QQ, Pages 98-9 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northerly side of Alice Farr Drive at the joint front corner of Lots 79 & 80 and running thence with the common line of said lots N. 16-30 W. 178.8 feet to an iron pin; thence N. 71-32 E. 100.2 feet to an iron pin; thence S. 16-30 E. 182.5 feet to an iron pin on the northerly side of Alice Farr Drive; thence with said drive S. 73-30 W. 100 feet to the point of beginning.
