All that certain piece, parcel or tract of land lying and being on the northwesterly side of Hammett Road, sometimes referred to as Cardinal Lane, and containing Four (4) acres according to a plat entitled "Property of Hugh B. and Ann Marlar", made by H. S. Brockman, dated October 19, 1959, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at a nail in the center of Hammett Road, joint corner with property of Brewer, and running thence along the center of said road, N 34-40 E, 150.0 feet to a nail; thence continuing with the center of said road N 39-10 E, 300.0 feet to a nail; thence leaving said road and along property of the Estate of Eula L. Hammett, N 37-20 W, 346.0 feet to an iron pin; thence S 52-40 W, 435.2 feet to an iron pin in the line of Brewer; thence along the Brewer line S 37-20 E, 463.2 feet to a nail, the point of beginning.

The above described property is conveyed subject to the following restrictions:

- 1. This property shall be used for residential purposes only.
- 2. No dwelling shall be erected on this property costing less than \$11,000.00.
- 3. No lot shall be subdivided out of this tract to contain less than 15,000 square feet.
- 4. No more than four (4) resident dwellings shall be erected on said tract.
- 5. No trailor, basement, tent, shack, garage, barn or other outbuilding erected on the tract shall at any time be used as a residence, temporarily or permanently, nor shall any structure of a temporary character be used as a residence.
- 6. No noxious or offensive trade or activity shall be **xxxxxxx** carried on upon said tract, nor shall anything be done thereon which may be or become a nuisance to the neighborhood.
- 7. All sewage desposal shall be by septic tank meeting the approval of the State board of Health, or municipal sewerage system.
- 8. No hogs or hog pens shall be kept or maintained on said premises, and no cows, chickens or other domestic fowl or animals shall be raised on said premises ona commercial basis.
