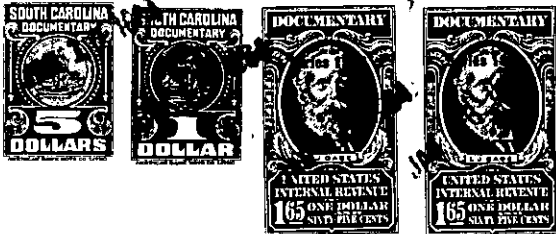
in consideration of Twenty Nine Hundred Twenty Five and No/100----- Dollars,
