1. No building is to be erected or used for commercial purposes on said lots (Lots 1, 2, 3, 4, 5 and 6 in subdivision are designated for Commercial purposes).

2. Any dwelling erected on said lots shall be at least 30 feet from any street on which it fronts; shall contain at least 1200 sq. feet of floor space on first floor, exclusive of porches and garages, shall be completed before being occupied; and shall be equipped with a satisfactory septic tank or connected to sewer.

3. No outbuildings with the exception of a garage shall be erected within 75 ft. of any street on which lots front.

4. No pigs or goats are to be kept on said lots

No pigs or goats are to be kept on said lots.

5. Any fence erected or used for the retention of animals other than domestic pets shall be at least 125 feet from any street on which lot fronts.
