to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said W. N. Leslie, his heirs and assigns forever,

All my right, title and interest in and to that certain tract of land in Greenville County, State of South Carolina, in Chick Springs Township, containing 10 acres, more or less, and being more particularly described according to a survey and plat by Piedmont Engineers and Architects on April 15, 1964, as follows:
