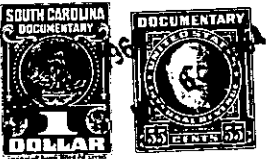

the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and  
release unto

All that certain piece, parcel or lot of land situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot #5 of a subdivision known as Welcome Acres, as shown on a plat thereof prepared by Piedmont Engineering Service, dated July 1963, recorded in the R. M. C. Office for Greenville, County in Plat Book DDD, at Page 44, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Welcome Road, joint front corner lots #4 and #5, running thence along the line of these lots, N. 37-09 E. 170.3 feet to an iron pin at the joint rear corner of said lots; running thence along the rear line of lot #6, S. 50-11 E. 90.0 feet to an iron pin on the western side of Cole Road; thence along the western side of Cole Road S. 30-02 W. 130 feet to an iron pin at an intersection, which intersection is curved, the chord of which is S. 75-29 W. 35.3 feet to an iron pin on the northern side of Welcome Road; thence along the northern side of Welcome Road, N. 59-25 W. 85.0 feet to an iron pin, point of beginning.
