All that piece, parcel or lot of land situate in Chick Springs Township, Greenville County, State of South Carolina, on the southwestern side of Henderson Circle and being known and designated as Lot No. 1 on plat of property of T. A. Long prepared by M. H. Woodward, and being a portion of Lot No. 9 on plat of Property of Paul L. Henderson recorded in the R. M. C. Office for Greenville County in Plat Book "T", at Page 264 and having, according to said Long plat, the following metes and bounds, to-wit:
