KNOW ALL MEN BY THESE PRESENTS, that I, Tom S. Bruce, as Trustee,

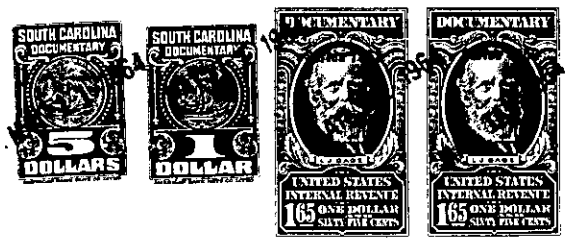
in consideration of Twenty Eight Hundred Forty Five and 25/100 (\$2845.25)----- Dollars,
