JERRY DONALD WOOD:

All that piece, parcel or lot of land situate, lying and being on the Northern side of Shubuta Drive near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 71 as shown on a plat of Farmington Acres, prepared by Carolina Engineering & Surveying Co., dated December, 1962, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book RR at pages 106 and 107, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Northern side of Shubuta Drive at the joint front corner of Lots Nos. 70 and 71, and running thence with the line of Lot No. 70 N. 37-15 W. 150 feet to an iron pin; thence with the rear line of Lot No. 62 S. 52-45 W. 90 feet to an iron pin at the joint rear corner of Lots Nos. 71 and 72; thence with the line of Lot No. 72 S. 37-15 E. 150 feet to an iron pin on the Northern side of Shubuta Drive; thence with the Northern side of Shubuta Drive N. 52-45 E. 90 feet to the point of beginning.
