the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Vernon La Von Brock, his heirs and assigns forever:

ALL that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina, being known and designated as Lot No. 71 of Conestee as shown on a plat thereof, made by R.E. Dalton, Engr., dated December, 1943, recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book K at page 276, and having the following metes and bounds, to-wit:
