All that piece, parcel or lot of land lying, being and situate in Chick Springs Township, on the west side of Sumter Street, near the Town of Greer, in County and State aforesaid, and being known and designated as Lot No. 43 on plat of Development No. 2, Victor-Monaghan Co., Division of J. P. Stevens & Co., Inc., Greer Plant, prepared by Dalton & Neves, Engineers, April, 1947 and recorded in the R. M. C.
