McCauley and Alma B. McCauley, their heirs and assigns,

All that piece, parcel or lot of land lying and being on the northwestern side of Paris Mountain Farms, recorded in Plat Book N at Page 13, and being more particularly described as follows:

BEGINNING at an iron pin on the northwestern side of Paris Mountain Road, at the joint front corner of Lots 1 and 2, and running thence with line of Lot 2, N. 41-30 W. 157 feet to pin; thence S. 3-45 W. 243 feet to pin on the northwestern side of Paris Mountain Road; thence along the northwestern side of Paris Mountain Road, N. 38-35 E. 94.5 feet to point; thence continuing with the northwestern side of said Road, N. 48-30 E. 78 feet to the beginning corner.
