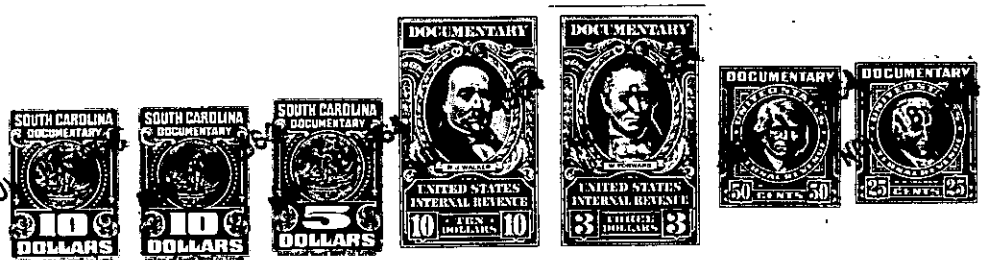
That I, R. D. Wilson,
