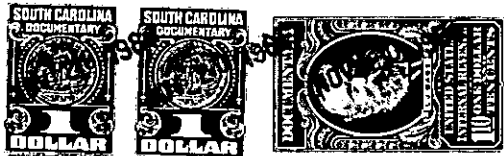
in consideration of ONE THOUSAND AND NO/100 (\$1,000.00)-----Dollars,
